

**ORDINANCE NO. 2079**

**AN ORDINANCE  
AMENDING SECTION 2.146 OF ARTICLE XIX OF CHAPTER 2 OF THE  
VILLAGE OF RANTOUL CODE-1977, AS SUPPLEMENTED AND AMENDED,  
IN CONNECTION WITH THE COMPOSITION OF THE PLAN COMMISSION**

**WHEREAS**, the Plan Commission of and for the Village of Rantoul, Champaign County, Illinois (the “**Village**”) is and has been duly established as provided in Article XIX, entitled “**RANTOUL PLAN COMMISSION**” of CHAPTER 2, entitled “**ADMINISTRATION**” of the Village of Rantoul Code-1977, as supplemented and amended, including by Section 3, entitled “**PLAN COMMISSION**” of TITLE XXI, entitled “**ADMINISTRATION, PERMITS, FEES AND PENALTIES**”, of the Village of Rantoul Zoning Ordinance-1991, as supplemented and amended; and

**WHEREAS**, the President and Board of Trustees of the Village desire to make provision for the position Vice Chair of the Plan Commission, a position which, if the Chairman is temporarily absent, shall have the power of a presiding officer at any meeting of the Plan Commission.

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF RANTOUL, ILLINOIS**, as follows:

**Section 1.** That Section 2.146, entitled “Establishment-Composition” of ARTICLE XIX, entitled “**RANTOUL PLAN COMMISSION**”, of CHAPTER 2, entitled “**ADMINISTRATION**”, of the Village of Rantoul Code-1977, as supplemented and amended, be and the same is hereby further supplemented and amended to provide as follows:

**Sec. 2.146 Establishment – Composition.**

There is hereby established a Plan Commission for the Village, which shall consist of seven (7) members. The members of the Plan commission shall reside within the Village or within territory contiguous to the Village and no more than one and one-half (1½) miles beyond the corporate limits of the Village and not included within any other municipality. All members of the Plan Commission shall be appointed by the President of the Board of Trustees for a term of four (4) years, subject to confirmation by the Board of Trustees. Any vacancy shall be filled for the remainder of the unexpired term in the same manner.


The President of the Board of Trustees, subject to confirmation of the Board of Trustees, shall designate one of the members of the Plan Commission as its Chairman.

The Plan Commission may elect a Vice Chair and such other officers, and make such rules, by-laws and regulations as it may deem proper for the conduct of its work, provided that any such rules, by-laws or regulations are not inconsistent with the Illinois Municipal Code, this Article or any other ordinance adopted by the Village. The Vice Chair shall have the power of a presiding officer at any meeting of the Plan Commission if the Chair is absent from such meeting.


**Section 2. Effective Date.** The provisions of this ordinance shall become effective ten (10) days after its passage, approval and publication as provided by law.

This ordinance is hereby passed, the “ayes” and “nays” being called, by the concurrence of a majority of the members of the Corporate Authorities then holding office at a rescheduled regular meeting on the date set forth below.
