



**AN ORDINANCE
ESTABLISHING A SCHEDULE OF MONTHLY
ELECTRIC RATES AND SERVICE CHARGES EFFECTIVE MAY 1, 2007**

WHEREAS, the Village of Rantoul, Champaign County, Illinois (the “Village”) is a municipality and a home rule unit under Section 6, Article VII of the Constitution of the State of Illinois; and

WHEREAS, as a home rule unit, the Village has the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs, that protect the public health, safety and welfare of its citizens, that license, that tax and that incur debt; and

WHEREAS, the Village owns and operates its own electric system (the “System”); and

WHEREAS, in addition to the Village’s power as a home rule municipality, the provisions, among others, of Sections 11-117-12 and 11-119-3 of the Illinois Municipal Code (65 ILCS 5/11-117-12 and 5/11-119-3), as supplemented and amended, authorize the Village to establish, revise and maintain by ordinance charges or rates which will be sufficient at all times to operate and maintain the System.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF RANTOUL, CHAMPAIGN COUNTY, ILLINOIS, as follows:

Section 1. Schedule of Monthly Electric Rates and Service Charges. The Schedule of Monthly Electric Rates and Service Charges, as attached hereto and hereby incorporated herein by this reference thereto, is hereby established for the System effective as of May 1 of each of the years of 2007, 2008 and 2009.


Section 2. Effective Date. The provisions of this Ordinance shall become effective following its passage, approval and publication as required by law. The respective rates or service charges as established in the Schedule of Electric Rates and Service Charges shall apply to all electric service purchased for use or consumption and all applicable service charges incurred on or after May 1, 2007.

Section 3. Conflict. All ordinances or parts of ordinances which are in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby superseded.


Section 4. Publication. The Village Clerk is hereby authorized and directed to cause this Ordinance to be published in pamphlet form.
